- 5. 10% Bid Bond and 100% Performance/Payment Bond required
- 6. The project **is not** subject to State of Ohio Prevailing Wage requirements.

- Bid Alternates Base Bid is Paw Paw Camp Shelter & Restroom; Alt 1 is White Oak Camp – Two Shelters and Restroom; Alt 2 is Dogwood Camp – Pond Overlook Shelter
- 9. Allowance for field changes \$1,000.00 Expect bid addendum to include new Bid Breakdown Form which includes this item
- 10. Liquidated damages are \$100.00 for each calendar day of delay in the completion of the work as liquidated damages for extended administrative expense; plus \$100.00 for each additional inspection required beyond the Contract Completion Date, as liquidated damages for extended construction inspection expense.
- 11. Allowances for weather related delays see Page 48, Para 19.4(b)
- 12. Building Permits none required

Changes to the Special Conditions of the Contract:

The Special Conditions of the Contract, as shown on Page 78 of the Bid Document shall be replaced in their entirety by the following:

- 1. The Contractor shall coordinate with the Owner so that work will not be performed at any Shelter building (which includes Dogwood Pavilion), on days when that structure is reserved for use by the public.
- 2. The Contractor shall allow for a total of five days' suspension of work, in their bid and schedule, to accommodate reservations made prior to the approval of the Contractor's work schedule. The Owner shall provide the dates of any previously scheduled reservations prior to the Contractor's submission of their proposed schedule. If more than five days are required, the Owner will make an appropriate adjustment to the Contract Time and Price.
- 3. Upon approval of the Contractor's schedule, the Owner will not accept new reservations that conflict with the approved schedule.
- 4. The Owner will make their best effort to ensure that at least one structure is ready for work on each workday of the Contract Time.
- 5. No work shall be performed at Shelter buildings on Saturdays, Sundays, or Federal holidays.
- 6. The Contractor shall not have more than two Shelter buildings unavailable simultaneously.
- 7. The restroom buildings at Paw Paw Camp and White Oak Camp shall remain

HILLS & DALES METROPARK TIMBER LOG REPAIR PROJECT Addendum 01 March 21.2024 Page 2 of 3 open for use by the public during regular park hours. Limited-time closures to avoid overhead hazards to the public while working on those buildings shall be coordinated with the Owner.

8. The Contractor shall not store equipment or materials in the vicinity of the Shelter buildings, or on lawns or under trees. The Owner will designate spaces in the parking lot at each work area for storage of materials and equipment.
